Pro Shop had sidewalk sale which was very successful. Maintenance completed sod on the #15 tee box. This box will come into play in the Spring of 2025. Work completed on #12 tee box including sod and wall construction. New scorecards are in and being used at this time. Greens Committee is now active. Pro Shop at full staff. Purple stickers are

being issued as members pay MGA membership fee. Mats will be used on driving range Saturday through Tuesdays. Final three green covers have arrived and are positioned on the course to be used as necessary. There will be no new sod or grass seeds in budget for this coming year. Covers were not utilized during recent freezing weather after Jeff and John agreed that they were not considered appropriate for that event. Jeff indicated the proshop was ready for the upcoming Super Bowl Tournament (February 8, 2025)

New Business/ Open Discussion:
